


भारी बारिश और दरकते पहाड़ों से संकट बढ़ा

औरों की जान बचाने के लिए दे दी अपनी जान
मंडी, 14 अगस्त (जनसत्ता)।

शिमला/मंडी, 14 अगस्त (ब्यूरो/जनसत्ता)।

पिछले दो दिन से जारी बरसात ने हिमाचल प्रदेश में फिर से रौद्र रूप दिखाया। भारी बरसात, बादल फटने, भूस्खलन से अनेक मकान, इमारतें व रास्ते बह गए। सोमवार को प्रदेश में भूस्खलन व बरसात से हुए हादसों में 50 से अधिक लोगों की मौत हो गई। शिमला के समरहिल इलाके का शिव मंदिर भूस्खलन की चपेट में आ गया, जिसमें 15 लोगों के दबने की सूचना है। सोलन के ममलीग के जड़ौण गांव में देर रात करीब डेढ़ बजे बादल फटने से एक परिवार के सात लोगों की मौत हो गई। वहीं, मंडी में मकान गिरने से एक परिवार के सात लोग दब गए। इन सभी के शवों को निकाल लिया गया है।



मकान गिरने से सात लोगों की मौत
मंडी: मंडी जिले के दरंग विधानसभा क्षेत्र के उतरसाल इलाका में सेगली बंबोला पंचायत के गांव चलाहर में मकान गिरने से परिवार के सात लोग दब गए। उनके शव निकाल लिए हैं। पुलिस अधीक्षक सोम्या साम्ब शिवन के अनुसार जिन लोगों की मृत्यु हुई, उनमें रमेश कुमार (28), कोनिक (दो) पुत्र रमेश कुमार, गायत्री देवी (19), रीना देवी (18), कमला देवी (43), तुगेश्वरी (7), हीरामणि (63) शामिल हैं। रविवार रात को इस घर में कोई कार्यक्रम था। 18 लोग घर में सोए थे। इनमें से सात लोगों की मृत्यु हो गई, जबकि छह घायल हैं।

अनेक सड़के बंद हो गई हैं। मोबाइल नेटवर्क, बिजली व्यवस्था बुरी तरह प्रभावित है। जो लोग जहां ठहरे थे, वहीं रुकने को मजबूर हो गए हैं।

सांभल में तीन मजदूरों बड़े

मंडी: आठ मील यानी सांभल गांव में छह लोग लापता हैं। इनमें से तीन कंपनी के टेकेदार के मजदूर हैं। यहां छह मजदूर वहां सोए थे। नाले में आए बाढ़ के पानी से तीन मजदूर जिला बिजनौर उत्तर प्रदेश से अनमोल, विक्की और गौरव बह गए।

मकान ढहा, परिवार में तीन मौत

मंडी: एक मकान में ढह जाने से परिवार के छह लोगों में से तीन लोगों की मौत हो गई। इस परिवार में एक महिला, दो बेटियां, बेटा, बहु तथा एक छह महीने की बच्ची सो रहे थे। एक बहु, बेटा और छह महीने की बच्ची की मौत हो गई।

धर्मपुर विधानसभा क्षेत्र के नलायाणा गांव में एक मकान पर लहसा गिरने के कारण उस घर के सदस्यों को बाहर निकालते समय पूर्व प्रधान प्रभास राणा उसकी चपेट में आ गए। इस हादसे में उनकी मौत हो गई। पूर्व जिला परिषद सदस्य एवं राज्य श्रमिक कल्याण बोर्ड के सदस्य भूपेंद्र सिंह ने बताया कि प्रभास राणा कालेज समय से ही सामाजिक कार्यकर्ता के रूप में कार्य करते थे।

मंडी में तबाही के बाद रास्ते बंद, लोग घरों में कैद



मंडी, 14 अगस्त (जनसत्ता)।

हिमाचल के इतिहास में सबसे अधिक प्रलयकारी बारिश का कहर जारी है। सोमवार को एक ही दिन में जमींदोज हुए मकानों में कई लोग जिंदा दफन हो गए। पिछले दो दिन से लगातार हो रही बारिश ने जिले में प्रलय जैसे हालात पैदा कर दिए।

मंडी के पास स्कोर खोबला गांव में बाढ़ के पानी से मकान को बचाने में लगी 50 साल की कागदू पत्नी अमर चंद तेज बहाव में बह गई। मसेरन गांव पंचायत मझवाड़ में मकान बह जाने से मीना देवी तथा उसकी दोहती कृतिका बह गई। दोनों के शव बरामद नहीं। निहरी क्षेत्र में दो लोगों के जिंदा दफन हो जाने का समाचार है। बल्ह घाटी के गांव मलवाणा में 26 साल के अशु की मकान के नीचे दब जाने से मौत हो गई। मंडी पंडोह मार्ग पर आठ

मील में तीन मजदूर ऊपर से आए मलबे के साथ बह गए। पूरे जिले में अभी तक 21 लोगों के सोमवार को दब या बह जाने से मौत हो जाने की खबर है। अभी यह संख्या बढ़ सकती है क्योंकि पूरे जिला का संपर्क कटा हुआ है। बिजली के पोल ढह गए हैं, लाइनें टूट गई हैं, मोबाइल नेटवर्क भी ध्वस्त हो गया है। ऐसे में लोग घरों में ही कैद होकर रह गए हैं। जिले में कई जगह बादल फटने से बड़ी तबाही हुई है।

सांवल पंडोह में फटे बादल ने कई घर, खेत, गोशालाएं अपनी चपेट में लेकर तबाह कर दी हैं। नगर निगम मंडी के वार्ड नंबर चार शिल्हाकीपड़ में बादल फटने से कई घरों व संपत्ति को नुकसान हुआ है। सुंदरनगर के हराबाग में भी बादल फटा।

ब्यास नदी के बढ़े जलस्तर से बाढ़ का खतरा, सहमे लोग

हमीरपुर, 14 अगस्त (जनसत्ता)।

हमीरपुर में लगातार भारी वर्षा के कारण नदी, नाले और खड्ड पूरे उफान पर हैं। जनजीवन भी बुरी तरह प्रभावित है। लोग गांवों में बैठने को मजबूर हैं। ब्यास नदी का जलस्तर बढ़ने से बाढ़ जैसे हालात बने हुए हैं। कई जगह भूस्खलन होने से कई सड़के बंद हो गई। नादीन के औद्योगिक क्षेत्र में पानी भरने से कारोबार प्रभावित हुआ है। जलशक्ति विभाग के पंप हाउस और जलमन औद्योगिक क्षेत्र से करीब 20 लोगों को सुरक्षित निकाला गया है।

भौरंज उपमंडल के गांव लड़ायाणी में रविवार एक महिला

की मौत हुई। सोमवार को सुजानपुर के निकट जलशक्ति विभाग के पंप हाउस के पास हुए भूस्खलन में भी एक नेपाली महिला की मौत हुई है। हमीरपुर उपमंडल के गांव बगाटू में भी एक वृद्ध व्यक्ति की मौत हुई है। इनके अलावा नादीन उपमंडल के गांव रैल में एक महिला और बड़सर उपमंडल की ब्याड खड्ड में एक व्यक्ति के बहने की आशंका है। ये दोनों अभी लापता हैं। उपायुक्त हेमराज बैरवा ने बताया कि पिछले 24 घंटों के दौरान जिला में तीन लोगों की मौत हुई है और 2 लोग लापता हैं। अणु कला में भूस्खलन होने से पके मकानों व भवनों को नुकसान पहुंचा है।
